14	Q. By whom are you employed and in what capacity?		
15	A. I am employed by the Missouri Public Service Commission (Commission) as a		
16	Utility Engineering Specialist III in the Energy Department of the Utility Operations Division.		
17	Q. Are you the same Michael E. Taylor who contributed to Staff's Cost-of-

21	Q. Has the Staff evaluated the La Cygne Unit 1 selective catalytic reduction		
22	(SCR) equipment utilizing the established in-service criteria?

24	Q. What were the results of those evaluations?		
25	A. The results are consistent with the established in-service criteria and were		
26	included as Appendix 2 to the Staff's Cost-of-Service Report filed in this case. However, the		
27	testing of the SCR had not been completed by March 31, 2007, the end of the update period		
28	for this case. The testing was completed on May 28, 2007, prior to the conclusion of the true-

up period (September 30, 2007) for this case. Staff is not aware of any issues that would prevent the costs of the SCR from being included in rate base for rate-making treatment.

- Q. What is your conclusion regarding in-service criteria for the La Cygne Unit 1 SCR?
- Based on my review and analysis of the data and inspection of the facilities, A. the La Cygne Unit 1 SCR should be considered fully operational and used for service.
 - Q. Does this conclude your true-up direct testimony?
 - A. Yes, it does.
