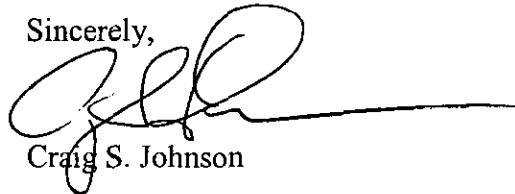

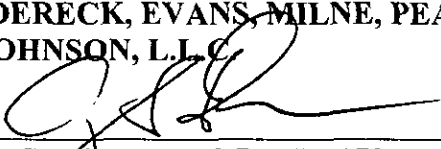

NOTICE OF DISMISSAL

Comes now Choctaw Telephone Company and MoKan Dial, Inc., and hereby notify the Commission that their complaints against T-Mobile USA, Inc., filed here in, can be dismissed. Choctaw and MoKan advise the Commission that they have reached a Traffic Termination Agreement with T-Mobile, which will be filed for approval with the Commission. 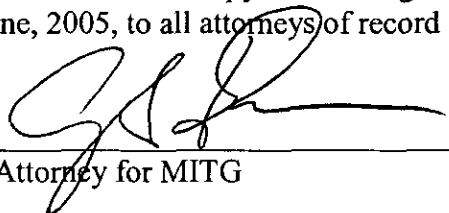
