**ORDER ACKNOWLEDGING CHANGE OF NAME**

On February 23, 2000, Ionex Communications, Inc. (Ionex) issued tariff sheets that revised the company's existing tariff to reflect the change of the name of the company from Feist Long Distance Service, Inc., to Ionex Communications, Inc. The tariff revisions indicated an effective date of February 24. Ionex also indicates that it adopts all previous filings made by Feist with the Missouri Public Service Commission as its own. On February 29, the Staff of the Commission filed a recommendation and memorandum recommending that the Commission approve the requested name change and the tariff sheets as submitted.


