NOTICE ACKNOWLEDGING ELECTION OF WAIVERS -**CENTURYLINK**

Issue Date: December 9, 2013

On November 21, 2013, Spectra Communications Group, LLC, d/b/a CenturyLink filed a notice of election for waiver of an additional statutory provision in addition to the statutory and rule provisions it has previously elected to waive. Specifically CenturyLink has elected to waive subsections 1 and 4 of Section 392.245, RSMo. CenturyLink is authorized to elect the waiver of that statute by Section 392.420, RSMo, as amended by Senate Bill 237 in 2013. CenturyLink does not need the permission of the Commission to elect that waiver and the waiver took effect at the time it filed its notice.

Previously CenturyLink had elected a standard list of waivers identified by Staff in a motion filed in this case on October 18, 2011. On December 9, 2013 Staff filed a recommendation confirming CenturyLink's election to waive application of subsection 1 and 4 of section 392.245. So that a clear record of those waivers is established, the Commission will list all the statutory and regulatory sections that CenturyLink has waived, including the latest waiver.
