On March 17, 2006, NuVox Communications of Missouri, Inc., filed an application for an investigation into the Wire centers that AT&T Missouri asserts are non-impaired under the Federal Communications Commission's Triennial Review Remand Order.¹ Upon their requests, both McLeodUSA Telecommunications Services, Inc., and XO Communications Services, Inc., were granted intervention in this matter. Uncertain as to whether all telecommunications carriers in Missouri are aware of this proceeding, the Commission finds that notice of NuVox's application shall be sent to all interexchange and local exchange telecommunications companies.
