**TRAINING ADVISORY GROUP NOTIFICATION**

COMES NOW Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) and for its Training Advisory Group Notification, states as follows:

1. On October 6, 2011, the International Brotherhood of Electrical Workers Local 2, 309, 649, 702, 1439, 1455, AFL-CIO and International Union of Operating Engineers Local 148, AFL-CIO (“Unions”) and the Missouri Public Service Commission Staff (“Commission” and “Staff”) filed a Joint Motion requesting the Commission issue an order creating a Training Advisory Group and scheduling an initial meeting.
2. On October 12, 2011, the Commission issued an order creating the Training Advisory Group. The Order did not set an initial meeting date.
3. The Company has already had discussions with the Unions about the training program in order to put together a first draft of a proposal to present to other parties for comment.
4. To ensure all interested parties have the same information, the Company files this notice of its intention to hold the first meeting of the Training Advisory Group on November 17, 2011, at Ameren Missouri’s St. Louis offices, starting at 3:30 pm. The Company will have a telephone conference line or WebEx available for those in Jefferson City (or elsewhere) who do not wish to travel to the Company’s St. Louis office.

5. The Company will circulate a draft of its proposal prior to the meeting so that parties may provide constructive comment at this initial meeting. At that time, parties can discuss what additional work is needed from the group.

6. Copies of this pleading are being served upon the parties to Case No. ER-2011-0028, Ameren Missouri's last electric rate case. Parties that wish to participate should notify the Company at wtatro@ameren.com so that the Company can ensure all interested parties have received meeting information.
