## NOTICE AND ORDER DIRECTING STAFF TO FILE A RECOMMENDATION

On March 1, 2023, Corcom Communications, Inc. filed a request to cancel the certificate of service authority granted to Corcom Communications, Inc. to provide interexchange and non-switched local telecommunication service in the State of Missouri. The Commission granted Corcom Communications, Inc. a certificate of service authority to provide telecommunication service in the State of Missouri in File Number TA-2015-0342.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> The Commission finds that proper persons shall be allowed fifteen days from the issuance of this order to file a motion for hearing.

The Staff of the Commission (Staff) is directed to review the request and file a recommendation regarding the cancellation of Corcom Communications' certificate of service authority and accompanying tariff, if there is one.

**THE COMMISSION ORDERS THAT:**

1. Any party wishing to file an objection or request a hearing shall do so by filing a pleading no later than March 17, 2023, with:

2. On or before April 17, 2023, Staff shall file a recommendation regarding the request to cancel the certificates of service authority and any accompanying tariff of Corcom Communications, Inc.
