On November 8, 2016, the Staff of the Missouri Public Service Commission (Staff) filed a *Motion to Consolidate* the small company sewer and water rate increase requests in the above captioned cases. The Commission received no response to the motion within the time provided by regulation.<sup>1</sup> In support of its request, Staff cites the administrative efficiency and economy of resources provided by the consolidation of the cases. The small utility companies serve the same customer service areas and have the same ownership in common. Therefore, the Commission will grant the motion.

## THE COMMISSION ORDERS THAT:

1. The *Motion to Consolidate* is granted.
2. These actions shall be consolidated under File No. SR-2017-0130.
