





## NOTICE OF LOCAL PUBLIC HEARING

### PROPOSED RATE INCREASE

The Missouri Public Service Commission has scheduled a local public hearing for January 13, 2004 at the Mid-County Fire Protection District building located at 184 N. Highway 5, Camdenton, Missouri, from 6:30 p.m. until 8:30 p.m. to hear public comments regarding Osage Water Company's proposed rate increase for base monthly water and sewer charges. OWC has proposed to increase its base monthly residential water charge to \$20.45, and its base monthly residential sewer charge to \$32.54, both of which represent a 25% increase over current base residential service rates. No change is proposed in OWC's commodity charge for water service in excess of 2,000 gallons per month.
