ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING REQUESTS TO INTERVENE, ESTABLISHING TIME FOR FILING RECOMMENDATIONS, AND GRANTING MOTION FOR EXPEDITED TREATMENT

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene, for the filing of recommendations, and granting the motion for expedited treatment.

On April 25, 2007, Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri filed an application and Motion for Expedited Treatment under 47 C.F.R. 52.15(g)(3)(iv), requesting that the Missouri Public Service Commission review and reverse a decision of the North American Numbering Plan Pooling Administrator (NANPA), NeuStar, Inc., to withhold certain numbering resources from AT&T Missouri. The numbering resources AT&T Missouri requested consist of a single thousands-block within the 636 NPA, and in the Festus-Crystal City rate center, and further, confined to the 8000-8499 XXXX range to

meet the needs of Holcim (US) Inc. The numbering resources are required in order to accommodate Holcim's new manufacturing facility in Bloomsdale, Missouri.

The Commission concludes that good cause has been shown pursuant to 4 CSR 240-2.080(16). The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

IT IS ORDERED THAT:

- Southwestern Bell Telelphone, L.P. d/b/a AT&T Missouri's Motion for Expedited Treatment is granted.
- 2. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.
- 3. Any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than May 14, 2007, with:
