APPLICATION FOR THE CANCELLATION OF CERTIFICATE OF SERVICE AUTHORITY AND WITHDRAWAL OF TARIFF(S)

COMES NOW 360networks (USA) inc. ("360 networks" or "Company"), pursuant to Section 392.410.5 RSMo and the Rules of the Missouri Public Service Commission ("Commission"), and hereby requests the Commission cancel its Certificate of Service Authority ("CSA") as well as any approved tariff. In support of its request, the Company states the following:

- 1. 360networks (USA) inc. is a Nevada corporation and a wholly-owned indirect subsidiary of Zayo Group, LLC ("Zayo"). 360networks' principal place of business is 400 Centennial Parkway, Suite 200, Louisville, Colorado 80027. A copy of the Company's Certificate of Authority to Transact Business is provided as Exhibit A. A copy of the Company's Certificate of Good Standing from the Missouri Secretary of State is provided hereto as Exhibit B.

- 4. In Missouri, 360networks is authorized to provide (1) basic local exchange telecommunications services pursuant to the CSA granted by the Commission in Case No. TA-2001-281 and (2) non-switched local exchange and interexchange pursuant to a CSA granted in Case No. TO-2001-99.
- 5. The Company does not provide telecommunications services in Missouri and has no intention of doing so in the future. The Company, therefore, no longer requires its CSA.
- 6. Because the Company does not serve any customers or have any active operations in Missouri, the Company respectfully submits that the surrender and cancellation of its CSA and withdrawal of its tariff(s) are reasonable and necessary.
- 7. The Company states that, to the best of its knowledge, (1) there are no annual reports or assessment fees that are overdue for the Company in Missouri and (2) the Company does not have any pending action or unsatisfied final judgments or decisions against it in any

state, federal agency or court which involves customers service or rates, which has occurred within three years of this Application.

8. The Commission has the authority to cancel a CSA pursuant to Section 392.410.5 RSMo (Supp. 2011), which provides that:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.

WHEREFORE, the Company respectfully requests that the Commission grant this Application and cancel the Certificate of Service Authority for 360networks (USA), inc. and withdraw its approved tariff(s) on file, together with such other and further relief as is necessary or convenient to affording the relief herein requested.


