# **ORDER GRANTING MOTION TO CONSOLIDATE**

On August 1, 2022, Confluence Rivers Utility Operating Company (Confluence Rivers) filed Applications requesting authority from the Commission to issue long-term debt, and to secure the long-term indebtedness by a statutory lien.

On August 2, in both cases, Confluence Rivers filed a motion to consolidate the cases, explaining that consolidation would aid in administrative efficiency and simplify requesting discovery and making filings by parties to these matters. Confluence Rivers is the applicant in both matters and that both matters involve common questions of law. Greater than ten days have elapsed and no objections were received.<sup>1</sup>

Commission Rule 20 CSR 4240-2.110(3) allows for the consolidation of cases with related questions of law or fact. Since these cases involve related questions of law and fact, the Commission will grant the motion.
