## SECTION 1 - TERMS AND ABBREVIATIONS

Individual Case Basis (ICB) - A service arrangement in which the regulation, rates, and charges are developed based on the specific circumstances of the case. Private line services will be made available to customers in a non-discriminatory manner. Rates for interexchange dedicated access, private line, non-switched services may be determined on an ICB. In such situations, ICB rates will be structured to recover the Company's cost of providing the service and will be made available to the Missouri Public Service Commission Staff upon request on a proprietary basis. ICB rates will not be used for switched services.

## SECTION 2 - RULES AND REGULATIONS (Cont'd)

### 2.14 Payment Arrangements

#### 2.14.1 Payment for Service

The Customer is responsible for the payment of all charges for facilities and services furnished by the Company to the Customer.

##### A. Taxes

The Customer is responsible for payment of any sales, use, gross receipts, excise, access or other local, state and federal taxes, charges or surcharges (however designated) (excluding taxes on the Company's net income) imposed on or based upon the provision, sale or use of the Company's services by Customer. Taxes and franchise fees will be itemized separately.

##### B. Universal Service Contributions

The Company shall recover from the Customer any contributions the Company is required to make as a result of the service provided to the Customer to any state or federal fund established to further universal access, telecommunications relay services, local number portability or similar government sanctioned funding mechanisms. In the event that any of the service provided to the Customer is exempt from such contribution requirements, the Customer shall provide, in a manner requested by the Company, documentation evidencing such exemption.

##### C. Commission Approval

All charges and fees subject to the Commission's jurisdiction, except taxes and franchise fees, not listed in this tariff will be submitted to the Commission for prior approval.
