- JUDGE PRIDGIN: Good morning. We're on the
- 3 record. This the pre-hearing conference in Case No.
- 4 WC-2008-0405, the staff of the Missouri Public Service
- 5 Commission versus Dale Whiteside and Whiteside Hidden
- 6 Acres, LLC.
- 7 I am Ron Pridgin. I'm the Regulatory Law Judge
- 8 assigned to preside over this prehearing conference. It's
- 9 being held on August 18th, 2008, at approximately 10:00 in
- 10 the morning. We are in the Governor's Office Building in
- 11 Jefferson City, Missouri.
- 12 I would like to get entries of appearance from
- 13 Counsel, please, beginning with the Staff of the
- 14 Commission.
- 15 MS. HERNANDEZ: Jennifer Hernandez and Steve
- 16 Reed for Staff of the Missouri Public Service Commission,
