Notification of Company Name Change and Replacement Tariff

Dear Mr. Woodruff,

West Safety Communications Inc. ("Company") hereby notifies the Commission that the Company has changed its name to Intrado Safety Communications, Inc. The Company respectfully requests that the Commission issue an updated certificate, if applicable, to reflect the Company's name as "Intrado Safety Communications, Inc." and update the Company name in all Commission records. The Company is authorized to provide basic local exchange and interexchange telecommunications services in Missouri pursuant to authority granted in Case No. TA-2002-154 and File No. CA-2011-0360 under the name of Intrado Communications Inc. The Company changed its name to West Safety Communications Inc. in File No. CN-2016-0220.

A copy of the Company's Amended Certificate of Authority of a Foreign Corporation on file with the Missouri Secretary of State is attached hereto as Exhibit A.

Attached hereto as Exhibit B is a replacement local telecommunications tariff, P.S.C. Mo. No. 1, with a requested effective date of April 12, 2020. This tariff, which replaces in its entirety the Company's P.S.C. No. 1 currently on file with the Commission, contains the same terms and conditions of service previously approved by the Commission. No changes have been made to the tariff except to reflect the Company's new name and to sequentially number the pages and correct section numbering as necessary.

The Company has changed its name as part of a recent rebranding and marketing campaign by its ultimate parent company, Intrado Corporation f/k/a West Corporation. The Company's name change does not entail any restructuring, merger or other transaction impacting the corporate existence or management of the Company. Customer notice is not required because the Company does not currently have any customers in Missouri.
