ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING REQUESTS TO INTERVENE, AND ESTABLISHING TIME FOR FILING RECOMMENDATIONS

This order directs that notice of the case be sent to all certificated basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filing of requests to intervene and for the filing of recommendations.

On November 29, 2005, Southwestern Bell Telephone, L.P., d/b/a SBC Missouri filed an application under 47 C.F.R. 52.15 requesting that the Commission overturn a decision of the North American Numbering Plan Administrator, NeuStar, Inc., to withhold three consecutive blocks of 1,000 numbers that it needs to provide service requested by Park Hill School District, a customer of SBC Missouri in the Kansas City rate center.

The Commission finds that proper persons should be allowed 7 days from the issuance of this order to file a request for intervention or a motion for hearing. The Commission will direct its Data Center to send a copy of this order to each certificated basic

local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to the North American Numbering Plan Administrator, NeuStar, Inc.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond must file a recommendation.

IT IS THEREFORE ORDERED:

- That the Data Center shall send a copy of this order to each certificated basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.
- 2. That any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than December 7, 2005, with:
