**ORDER APPROVING ADOPTION NOTICE FILED IN
COMPLIANCE WITH COMMISSION ORDER**

On September 9, 1997, the Commission issued its Order Recognizing Change of Corporate Name reflecting the former Post-Newsweek Cable, Inc.'s change of name to "Cable One, Inc." (Cable One). The Commission conditioned its recognition of the name change on the company's filing either an adoption notice or a new tariff reflecting the change of corporate name by October 9. On October 16, Cable One late-filed a pleading purporting to be an adoption notice effective on the date of filing which failed to comply with the requirements of 4 CSR 240-30.010(22). Cable One subsequently filed on October 21 an adoption notice with a November 20 effective date in compliance with 4 CSR 240-30.010(22).

On October 28, the Staff of the Public Service Commission (Staff) filed a Memorandum recommending approval of the adoption notice filed by Cable One on October 21. Staff states that it reviewed the proposed adoption notice and found it to be compliance with the Commission's September 9 order in this case. Staff notes that it is unaware of any other filings which may affect or be affected by the October 21 adoption notice filing.

The Commission has reviewed the October 16 and 21 filings, Staff's recommendation and the applicable rules and law in this case. The Commission will reject the October 16 pleading for failure to comply with 4 CSR 240-30.010(22). The Commission will grant leave to file out-of-time the October 21 adoption notice. The Commission finds the October 21 adoption notice to be in compliance with the Commission's September 9 order in this case and will approve the adoption notice for incorporation into the company's tariff.

IT IS THEREFORE ORDERED:

1. That the pleading entitled "Adoption Notice" filed on October 16, 1997, is rejected for failure to comply with 4 CSR 240-30.010(22).

2. That Cable One, Inc., is granted leave to late-file an adoption notice in compliance with the Commission's September 9, 1997, order in this case.

3. That the tariff sheet filed by Cable One, Inc., on October 21, 1997, is approved. The tariff sheet approved is:

4. That this order shall become effective on November 20, 1997.

5. That this case shall be closed on November 21, 1997.
