This additional waiver request is consistent with Staff's current list of standard waivers for telecommunications certificate applicants. As per the Commission's *Order* in File No. CE-2010-0077, WiMacTel requests the Commission find that good cause exists to grant a partial waiver of 4 CSR 240-32.050(4)(B) to the same extent that waiver was granted to AT&T-Missouri in Case No. IE-2009-0357, with the exception that WiMacTel may opt to instruct its end-user customers to use AT&T's toll-free number to receive a copy of the directory.

Revised tariffs will be filed consistent with these amended waiver requests and to address other issues raised by Staff in this matter.


