RESPONSE OF U.S. WATER COMPANY TO ORDER DIRECTING FILING


COMES NOW, U. S. WATER COMPANY, by and through the undersigned attorney,

- 1) On April 15, 2005, U.S. Water Company requested an extension of time within which to file Annual Report for the calendar year 2004.


