STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its response to the Commission's Order directing filing status report of depositions, states the following:

- 1. On April 27, 2010, Staff appeared at the Camden County Prosecuting Attorney's Office, 1 Court Circle, Camdenton, Missouri 65020 for the depositions issued by Commission ordered subpoena *duces tecum* for Cynthia Goldsby, Peter N. Brown, RPS Properties, L.P., Sally Stump, Vernon Stump, and John Summers.
- 2. Mr. Brown, Ms. Goldsby, Dr. Stump, and Mr. Summers were all served on April 15, 2010 and Notice was issued April 16, 2010. RPS Properties, L.P. was served on April 16, 2010 and Notice was issued on the same day. Ms. Stump was served on April 21, 2010 and Notice was filed on the same day.
 - 3. On April 22, 2010, Ms. Goldsby filed a motion to quash.
- 4. On April 23, 2010, RPS Properties, Dr. Stump and Mr. Summers filed a motion to quash.

- 5. On April 26, 2010, during the true-up hearing in this matter, Regulatory Law Judge made a ruling from the bench, denying Ms. Goldsby, RPS Properties, Dr. Stump and Mr. Summers' motion to quash.
- 6. Mr. Brown, Ms. Goldsby, RPS Properties, L.P., nor Ms. Stump appeared at the deposition on April 27, 2010.
- 7. Dr. Stump and Mr. Summers made an agreement with Staff to execute their subpoenas at a later date.
- 8. Ms. Stump filed a *Motion to Quash* on April 26, 2010. The motion is pending Commission decision.
- 9. Mr. Brown filed a *Motion to Quash and Request for Hearing* on April 23, 2010. Mr. Brown, Lake Region Water & Sewer Company (Lake Region) and Staff are requesting that the hearing be held on Monday May 3, 2010 at 1:00 pm.
- 10. During the evidentiary hearing, Judge Stearley requested Staff to file as an exhibit the "land sale contract" in which Mr. Summers indicated Lake Region provided to Staff through a data request. After review, Lake Region did not provide Staff with a "land sale contract" through a data request, thus Staff is unable to file it as an exhibit.

WHEREFORE Staff respectfully request that the Commission accept this *Status Report* and schedule a hearing for Peter N. Brown's *Motion to Quash* for May 3, 2010 at 1:00 pm.
