ORDER GRANTING EXTENSION

On February 25, 2022, Missouri-American Water Company (MAWC) filed an application (Application) requesting Certificates of Convenience and Necessity for a water and sewer system in an area of Pettis County, Missouri (Monsees Lake Estates Subdivision). The Staff of the Commission (Staff) filed its recommendation that the Commission approve the Application subject to certain conditions on June 9, 2022. Subsequently, the Commission directed responses due June 21, 2022.

On June 21, 2022, MAWC filed its response that it had no objections to the proposed recommendations and conditions. Also on June 21, 2022, the Office of the Public Counsel (OPC) filed its Motion for Extension.

OPC requests a one-week extension to complete its review of the workpapers underlying the recommendation of Staff. The Commission finds OPC's request to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. OPC's Motion for Extension is granted.

2. OPC is not required to respond, but if it wishes to respond to the recommendation of Staff, request a hearing, or request an extension of time, it shall do so on or before June 28, 2022.

3. This order shall be effective when issued.
