ORDER APPROVING INTERCONNECTION AGREEMENT

Issue Date: August 2, 2022

Effective Date: September 1, 2022

This order approves a negotiated Interconnection Agreement between the parties filed by Time Warner Cable Information Services (Missouri), LLC d/b/a Time Warner Cable (TWCIS).

On June 24, 2022, Time Warner Cable (TWCIS) filed an application with the Commission for approval of a negotiated Interconnection Agreement with MoKan Dial, Inc. under the provisions of the Federal Telecommunications Act of 1996. Time Warner Cable (TWCIS) is certificated with the Commission as an incumbent local exchange and interexchange carrier. MoKan Dial, Inc. is certificated with the Commission as a competitive local exchange and interexchange carrier.

Although MoKan Dial, Inc. is a party to the Agreement, it did not join in the application. On July 6, 2022, the Commission issued an order making MoKan Dial, Inc. a party in this case and directing any party wishing to request a hearing to do so no later than July 21, 2022. No requests for hearing were filed.

Under Section 252(e) of the Act, any Interconnection Agreement adopted by negotiation must be submitted to the Commission for approval. The Commission may

reject an Agreement if it finds that the Agreement is discriminatory or that it is not consistent with the public interest, convenience and necessity.

On July 22, 2022, the Staff of the Commission filed a recommendation. Staff recommends that the Agreement be approved and notes that the Agreement meets the limited requirements of the Act in that it is not discriminatory toward nonparties and is not against the public interest.

The Commission has considered the application, the supporting documentation, and Staff's recommendation. Based upon that review, the Commission finds that the Agreement meets the requirements of the Act in that it does not discriminate against a nonparty carrier and implementation of the Agreement is not inconsistent with the public interest, convenience and necessity.

The application represents that the applicant has not had contact with the Office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

THE COMMISSION ORDERS THAT:

1. The Interconnection Agreement between Time Warner Cable (TWCIS) and MoKan Dial, Inc., filed on June 24, 2022, is approved.
2. This order shall become effective on September 1, 2022.
3. This file may be closed on September 2, 2022.
