THIRD STATUS REPORT


Comes now Matrix Telecom, Inc., (hereinafter referred to as "Matrix") and Global Crossing Telecommunications, Inc., Global Crossing Local Services, Inc. and Global Crossing Telemanagement, Inc. (hereinafter referred to as "GC" or "Seller") (together the "Applicants"), by their undersigned counsel, and for their response to the Commission's July 29, 2005 Order state the following:

1. Applicants state that the transaction described in its application is not complete.
2. On April 29, 2005, Matrix filed its application for a certificate of service authority to provide basic local telecommunications service along with a proposed basic local tariff. Staff has discussed with the undersigned counsel certain changes to the basic local tariff and the finalization of those revisions is not yet complete.
3. Matrix is continuing to negotiate the terms of an interconnection agreement with Southwestern Bell Telephone Company (hereinafter referred to as "SWB") and has not yet filed an application for approval of an interconnection agreement. Matrix intends to seek approval by

the Commission of an interconnection agreement with SWB as soon as negotiations between Matrix and SWB are completed.


