**ORDER CANCELING TARIFFS AND CERTIFICATES OF  
CONVENIENCE AND NECESSITY**

On April 13, 2017, the Commission issued its *Order Authorizing Sale, Transfer, and Assignment of Water and Sewer Assets* ("Order"). The Order directed Lake Region Water & Sewer Company to notify the Commission once the transfer of assets to Camden County Public Water Supply District # 4 was completed and to cease providing water and sewer service immediately upon closing. Lake Region Water & Sewer Company filed its *Notice of Closing of Transfer of Assets* stating that the asset transfer was completed on June 29, 2017.

The Commission will therefore cancel Lake Region Water & Sewer Company's Certificates of Convenience and Necessity and tariffs.

**THE COMMISSION ORDERS THAT:**

1. Lake Region Water & Sewer Company's Certificates of Convenience and Necessity to provide water and sewer service are hereby canceled.
2. Lake Region Water & Sewer Company's tariffs are hereby canceled.
3. This order shall be effective when issued.
4. This file shall close on July 25, 2017.


