


**MOTION TO WITHDRAW APPLICATION FOR APPROVAL OF
A NEGOTIATED INTERCONNECTION AGREEMENT**

COMES NOW Phone-Link, Inc. ("Phone-Link") and hereby withdraws its Application for Approval of a Negotiated Interconnection Agreement between Phone-Link and Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company ("Southwestern Bell") filed on October 15, 2002 in the above-referenced matter. Although the Staff Recommendation was issued on November 13, 2002, the Interconnection Agreement has not yet received final approval. Phone-Link and Southwestern Bell are in the process of negotiating a revised Interconnection Agreement which would render the Agreement filed as part of Phone-Link's Application for Approval of a Negotiated Interconnection Agreement obsolete.


