**WITHDRAWAL OF MOTION FOR EXPEDITED
TREATMENT OF TARIFF FILING**

Primus Telecommunications, Inc. ("PTT") and Least Cost Routing, Inc. ("LCR," together "Applicants"), through undersigned counsel and pursuant to 4 CSR 240-2.080, hereby withdraw their Motion for Expedited Treatment of Tariff Filing filed in this matter on December 12, 2007, and respectfully state as follows:

1. As fully set forth in the Cover Letter of Exhibit 1 to the Motion for Expedited Treatment of Tariff Filing, Primus filed its Adoption Notice and Revised Title Page to the existing tariff of Least Cost Routing, Inc., establishing Primus' Tariff MO P.S.C. No. 3 for the provision of service to those customers that were served by Least Cost Routing, Inc. at the time the subject internal reorganization is approved by this Commission.

2. Said tariff sheets reflect a 30-day effective date (Issued date of December 12, 2007 and an Effective date of January 11, 2007). Applicants filed their Motion for Expedited Treatment, requesting that the Commission approve such tariffs to be effective on or before December 31, 2007, to coincide with the internal reorganization approval as requested in this matter.

3. However, it now appears that approval of the internal reorganization may not be obtained in all of the requisite state jurisdictions prior to the December 31, 2007 date. Thus, while Applicants are still desirous of this Commission's approval of the internal reorganization as soon as possible, and in conformance with the Staff Recommendation previously filed herein, it appears that expedited treatment of the pending tariff approval is no longer required. As a result, the subject tariff sheets can be approved effective January 11, 2007 as filed. To the extent that the internal reorganization approval is delayed in other jurisdictions resulting in a delay of the closing date beyond the January 11, 2007 date, Applicants will further extend the effective dates prior to January 11, 2007. Accordingly, Applicants respectfully request that the Commission's order approving tariff sheets provide that such "tariffs are approved effective January 11, 2007, or to the effective date as extended by Applicants to conform to the actual closing of the transaction approved herein."

WHEREFORE, Applicants respectfully withdraw their Motion for Expedited Treatment of Tariff Filing previously submitted on December 12, 2007, and request that the Commission grant the relief as requested herein.
