The applicants filed a motion to reconsider¹ the order² that extended the time for filing Staff's recommendation. In support, the applicants alleged that Staff asked for that extension to gather information that is irrelevant.³ Applicants' motion to reconsider also alleged that the extension risks the applicants' financing,⁴ so the Commission directed Staff to file its response in an expedited fashion.

Staff complied with that directive.⁵ Further, Staff included a motion for local public hearing and Staff's recommendation to deny the application. In support, the recommendation alleges an inter-relation of buyers' and sellers' personnel, an inflated purchase price, and a public detriment in the form of higher rates for the buyer's customers.
