

TERRITORIAL AGREEMENT  
MACON ELECTRIC COOPERATIVE

10-30-95

Land located in Adair, Knox, Shelby, Monroe, Randolph, Chariton, Linn, Sullivan, and Macon Counties of the State of Missouri, the perimeter of which is more particularly described as follows:

Southeast corner of Section 1, Township 54 North, Range 18 West, Chariton County, Missouri; thence West along the South line of Sections 1, 2, and 3 of Township 54 North, Range 18 West, Chariton County, Missouri, to the Southwest corner of said Section 3; thence North along the West line of said Section 3, to the Northwest corner of said Section 3, said point also being the Southeast corner of Section 33, Township 55 North, Range 18 West, Chariton County, Missouri; thence West along the South line of said Section 33, to the Southwest corner of said Section 33; thence North along the West line of Sections 33, 28, and 21 of Township 55 North, Range 18 West, Chariton County, Missouri, to the Northwest corner of said Section 21, said point also being the Southeast corner of Section 17, Township 55 North, Range 18 West, Chariton County, Missouri; thence West along the South line of Sections 17 and 18 of Township 55 North, Range 18 West, Chariton County, Missouri, to the Southwest corner of said Section 18; thence North along the West line of Sections 18, 7, and 6 of Township 55 North, Range 18 West, Chariton County, Missouri, to the Northwest corner of said Section 6, said point also being the Southwest corner of Section 31, Township 56 North, Range 18 West, Chariton County, Missouri; thence North along the West line of said Section 31, to the Northwest corner of said Section 31, said point also being the Southeast corner of Section 25, Township 56 North, Range 19 West, Chariton County, Missouri; thence West along the South line of Sections 25 and 26 of Township 56 North, Range 19 West, Chariton County, Missouri, to the Southwest corner of said Section 26; thence North along the West line of said Section 26, to the Northwest corner of said Section 26, said point also being the Southeast corner of Section 22, Township 56 North, Range 19 West, Chariton County, Missouri; thence West along the South line of Sections 22 and 21 of Township 56 North, Range 19 West, Chariton County, Missouri, to the Southwest corner of said Section 21; thence North along the West line of said Section 21, to the Northwest corner of said Section 21, said point also being the Southeast corner of Section 17, Township 56 North, Range 19 West, Chariton County, Missouri; thence West along the South line of said Section 17, to the Southwest corner of said Section 17; thence North along the West line of Sections 17 and 8, of Township 56 North, Range 19 West, Chariton County, Missouri, to the Northwest corner of said Section 8; thence East along the North line of said Section 8, to the Northwest corner of the Northeast Quarter of said Section 8, said point also being the Southwest corner of the East Half of Section 5, Township 56 North, Range 19 West, Chariton County, Missouri; thence North along the West line of the East Half of said Section 5, to the Northwest corner of the East Half of said Section 5, said point also being on the Chariton/Linn County line; thence East along the North line of the East Half of said Section 5, to the

said Section 16, said point also being the Southeast corner of the Northeast Quarter of the Southeast Quarter of Section 17, Township 58 North, Range 19 West, Linn County, Missouri; thence West along the South line of the Northeast Quarter of the Southeast Quarter of said Section 17, to the Southwest corner of the Northeast Quarter of the Southeast Quarter of said Section 17, said point also being the Northeast corner of the Southwest Quarter of the Southeast Quarter of said Section 17; thence South along the East line of the Southwest Quarter of the Southeast Quarter of said Section 17, to the Southeast corner of the Southwest Quarter of the Southeast Quarter of said Section 17, said point also being the Northeast corner of the West Half of the Northeast Quarter of Section 20, Township 58 North, Range 19 West, Linn County, Missouri; thence South along the East line of the West Half of the Northeast Quarter of said Section 20, to a point 300 feet North of the Southeast corner of the West Half of the Northeast Quarter of said Section 20; thence West parallel with and 300 feet North of the South line of the Northeast Quarter and the Northwest Quarter of said Section 20, to a point on the West line of the Northwest Quarter of said Section 20, said point also being on the East line of Section 19, Township 58 North, Range 19 West, Linn County, Missouri, said point being 300 feet North of the Southeast corner of the Northeast Quarter of said Section 19; thence South along the East line of the Northeast Quarter of said Section 19, to the Southeast corner of the Northeast Quarter of said Section 19; thence West along the South line of the Northeast Quarter of said Section 19, to the Southwest corner of the Northeast Quarter of said Section 19, said point also being the Northeast corner of the North Half of the Southwest Quarter of said Section 19; thence South along the East line of the North Half of the Southwest Quarter of said Section 19, to the Southeast corner of the North Half of the Southwest Quarter of the said Section 19; thence West along the South line of the North Half of the Southwest Quarter of said Section 19, to the Southwest corner of the North Half of the Southwest Quarter of said Section 19, said point also being on the East line of Section 24, Township 58 North, Range 20 West, Linn County, Missouri, said point being 850 feet, more or less, North of the Southeast corner of said Section 24; thence West parallel with and 850 feet North of the South line of said Section 24, to the West line of the East Half of said Section 24; thence North along the West line of the East Half of said Section 24, to the Northwest corner of the South Half of the Northeast Quarter of said Section 24; thence East along the North line of the South Half of the Northeast Quarter of said Section 24, to the Northeast corner of the South Half of the Northeast Quarter of said Section 24, said point also being the Southwest corner of the Northwest Quarter of the Northwest Quarter of Section 19, Township 58 North, Range 19 West, Linn County, Missouri; thence North along the West line

of the Northwest Quarter of the Northwest Quarter of the said Section 19, to the Northwest corner of the Northwest Quarter of the Northwest Quarter of said Section 19, said point also being the Southeast corner of Section 13, Township 58 North, Range 20 West, Linn County, Missouri; thence West along the South line of said Section 13, to the Southwest corner of the East Half of the East Half of the said Section 13; thence North along the West line of the East Half of the East Half of Sections 13, 12, and 1 of Township 58 North, Range 20 West, Linn County, Missouri, to the Northwest corner of the East Half of the East Half of said Section 1; thence East along the North line of said Section 1, to the Northeast corner of said Section 1, said point also being the Northwest corner of Section 6, Township 58 North, Range 19 West, Linn County, Missouri; thence East along the North line of Sections 6 and 5 of Township 58 North, Range 19 West, Linn County, Missouri, to the Northeast corner of said Section 5, said point also being the Southwest corner of Section 33, Township 59 North, Range 19 West, Linn County, Missouri; thence North along the West line of Section 33, to the Northwest corner of said Section 33; thence East along the North line of said Section 33, to the Northeast corner of said Section 33, said point also being the Southwest corner of Section 27, Township 59 North, Range 19 West, Linn County, Missouri; thence North along the West line of said Section 27, to the Northwest corner of said Section 27; thence East along the North line of said Section 27, to the Northeast corner of said Section 27, said point also being the Southwest corner of Section 23, Township 59 North, Range 19 West, Linn County, Missouri; thence North along the West line of said Section 23, to the Northwest corner of said Section 23; thence East along the North line of said Section 23, to the Northeast corner of said Section 23, said point also being the Southwest corner of Section 13, Township 59 North, Range 19 West, Linn County, Missouri; thence North along the West line of said Section 13, to the Northwest corner of said Section 13; thence East along the North line of said Section 13, to the Northeast corner of said Section 13, said point also being the Southwest corner of Section 7, Township 59 North, Range 18 West, Linn County, Missouri; thence North along the West line of Sections 7 and 6 of Township 59 North, Range 18 West, Linn County, Missouri, to the Northwest corner of said Section 6; thence East along the North line of said Section 6, to the Northeast corner of said Section 6, said point also being the Southwest corner of Section 32, Township 60 North, Range 18 West, Linn County, Missouri; thence North along the West line of Sections 32 and 29 of Township 60 North, Range 18 West, to the Northwest corner of said Section 29; thence East along the North line of said Section 29, to the Northeast corner of said Section 29, said point also being the Southwest corner of Section 21, Township 60 North, Range 18 West, Linn County, Missouri; thence North along the West line

of Sections 21, 16, and 9 of Township 60 North, Range 18 West, Linn County, Missouri, to the Northwest corner of said Section 9, said point also being on the Linn/Sullivan County line, said point also being on the South line of Section 33, Township 61 North, Range 18 West, Sullivan County, Missouri; thence West along the South line of said Section 33, to the Southwest corner of said Section 33; thence North along the West line of Sections 33, 28, and 21 of Township 61 North, Range 18 West, Sullivan County, Missouri, to the Northwest corner of said Section 21; thence East along the North line of Sections 21, 22, 23, and 24 of Township 61 North, Range 18 West, Sullivan County, Missouri, to the Northeast corner of said Section 24, said point also being on the Sullivan/Adair County line, said point also being on the West line of Section 19, Township 61 North, Range 17 West, Adair County, Missouri; thence North along the Sullivan/Adair County line (also being the West line of said Section 19), to the Northwest corner of said Section 19 and the point of beginning.

**NOTE:**

Wherever in the foregoing description a corner is stated to be the same as and/or to coincide with another corner, and when in fact, such corners are not the same and/or do not coincide with one another, they shall be treated as if they are the same and do coincide.
