On July 15, 1999, Computer Business Sciences, Inc. filed its Application seeking authority to provide facilities-based Basic Local Telecommunications and Interexchange Service in the State of Missouri and to classify said service and the company as competitive. Said filing included the following tariffs:

PSC MO No. 1, Original PSC Sheet Nos. 1 through 48 (Local Exchange Tariffs)
PSC MO No. 2, Original PSC Sheet Nos. 1 through 22 (Interexchange Tariffs)
PSC MO No. 3, Original Sheet No. 1 (Carrier to Carrier Tariff)

These tariff sheets all bear an issue date of July 15, 1999, and an effective date of August 29, 1999.

PSC MO No. 3, Original Sheet No. 1 to **January 31, 2000**.
