

Stipulation as to Proportion of InterMTA Traffic

Comes now Petitioner Mid-Missouri Telephone Company and Respondent Sprint Spectrum L.P. d/b/a Sprint PCS ("Sprint PCS"), and hereby submit the following Stipulation with respect to traffic originated by Respondent Sprint PCS or Sprint Spectrum, L.P., and terminated to Petitioner Mid-Missouri Telephone Company, between February 5, 1998 and December 31, 2001, which traffic is the subject matter of this Stipulation, and which traffic is hereinafter referred to as the "subject matter traffic":

1. Of the subject matter traffic, the percentage of such traffic that is interMTA in jurisdiction is forty-three percent (43%). InterMTA traffic is subject to Petitioner's Missouri intraLATA access rate.

2. This stipulation is binding upon all signatories hereto.
