## ORDER SCHEDULING A PROCEDURAL CONFERENCE

On September 30, 2016, the Commission's Staff filed these complaints against Missouri Utilities Company and its court appointed receiver, Gary Cover, alleging that the company has failed to pay its 2014 assessment to the Commission. The Respondents filed a timely answer on October 10. The Commission now must determine how to proceed to consider the complaint.

To assist in that determination, the Commission will schedule a conference at which the parties may discuss the establishment of a procedural schedule. The parties may also discuss discovery questions and any other matters that may arise.

1. A procedural conference is scheduled for November 21, 2016, at 10:00 a.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. 
