ORDER DIRECTING STAFF TO FILE A STATUS REPORT

Issue Date: October 12, 2018 Effective Date: October 12, 2018

The Commission opened this case on August 28, 2018, at the request of its Staff, to address the compliance of certain Missouri water corporations with the requirements of Senate Bill 705, which has been codified at section 393.358, RSMo. That statute requires water corporations that serve more than 1,000 customers to develop a qualification process, and make that process open to all contractors seeking to provide construction and construction-related services on the water corporation's distribution system. Further, subsection 393.358.3, RSMo requires those water corporations to file a statement within thirty days after August 28, 2018, confirming that they have established the required qualification process. The Commission is given authority to verify the statements to ensure compliance.

The Commission's August 28 order required the six Missouri water corporations with more than 1,000 customers to which the new statutory requirement applies - Missouri-American Water Company, The Empire District Electric Company, Liberty Utilities (Missouri Water) LLC, Raytown Water Company, RDE Water Company, and Terre Du Lac Utilities Corporation - to file the statements required by law no later than September 27, 2018.

Missouri-American, Empire, Liberty Utilities, and Terre Du Lac Utilities have filed the required statements: Raytown Water and RDE have not.

The Commission will order its Staff to file a status report regarding the compliance of the water corporations with the statutory requirements, including Staff's recommendation on how the Commission should proceed regarding any such water corporations that have not complied with those requirements.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Staff shall file the status report described in the body of this order no later than October 31, 2018.
 - 2. This order shall be effective when issued.
