## **ORDER CONSOLIDATING CASES**

Issue Date: October 10, 2007 Effective Date: October 17, 2007

This order consolidates two pending cases pertaining to Respondents Central Jefferson County Utilities, Inc., Raintree Plantation, Inc., Jeremiah Nixon, Kenneth McClain, Norville McClain, and the Norville McClain Trust, which involve related questions of law and fact and would best be adjudicated together, rather than separately.

In Case No. WC-2007-0394, which was filed on April 13, 2007, the Staff of the Missouri Public Service Commission alleges that one or more of the Respondents have provided unsafe and inadequate water services to the residents of approximately 681 homes in the Raintree Plantation Subdivision in Jefferson County, Missouri. Staff seeks a Commission order finding that one or more of the Respondents have violated Section 393.130.1<sup>1</sup> and Commission Rule 4 CSR 240-60.020 by their conduct with respect to the Subdivision's water systems. Staff also seeks an order authorizing the Commission's General Counsel to seek monetary penalties in circuit court against one or more of the Respondents for the alleged violations pursuant to Sections 386.570 and 386.600.

In Case No. SC-2007-0396, which was also filed on April 13, 2007, Staff alleges that one or more of the Respondents have provided unsafe and inadequate sewer services to the residents of the same Subdivision. Staff seeks exactly the same relief as in Case No. WC-2007-0394.

Commission Rule 4 CSR 240-2.110(3) states that "[w]hen pending actions involve related questions of law or fact, the commission may order a joint hearing of any or all of the matters at issue, and may make other orders concerning cases before it to avoid unnecessary costs or delay." Likewise, Commission Rule 4 CSR 240-2.070(12) permits all matters upon which a complaint may be founded to be joined in a single hearing.

At the conclusion of a recent motion hearing conducted on October 1, 2007, counsel for Central Jefferson County Utilities, Inc. made an oral motion to consolidate Case Nos. WC-2007-0394 and SC-2007-0396, and the Commission's General Counsel indicated that Staff had no objection to consolidating them.<sup>2</sup> The Commission finds that the two cases clearly involve related questions of both law and fact, and that consolidating them would avoid unnecessary delay in adjudication and promote uniformity and efficiency without impairing the substantive or procedural rights of any party. Accordingly, the motion is granted and the two cases will be consolidated.

## IT IS ORDERED THAT:

1. Case No. SC-2007-0396 is hereby consolidated with Case No. WC-2007-0394 for all adjudicative purposes, including hearing and disposition. Case No. WC-2007-0394 will be the lead case and the style shall be "The Staff of the Missouri Public Service Commission, Complainant, v. Central Jefferson County Utilities, Inc., Raintree Plantation, Inc., Jeremiah Nixon, Kenneth McClain, Norville McClain, and the Norville McClain Trust, Respondents."
