STAFF'S VOLUNTARY DISMISSAL

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Voluntary Dismissal*, hereby advises the Commission as follows:

- 1. On July 10, 2014, Staff filed its *Complaint* against Respondent Moore Bend Water Utility, LLC ("Moore Bend"), alleging (1) that Moore Bend had taken certain actions prior to the effective date of the Commission order authorizing them and (2) that Moore Bend had failed to provide safe and adequate service because it was under a boil order due to bacterial contamination of its water source and had not implemented certain corrective measures specified by the Missouri Department of Natural Resources ("DNR").
- 2. Staff and the Company agreed to mediate. In the course of the mediation, Staff advised the Company and the Mediator that Staff would dismiss the *Complaint* as soon as Moore Bend had satisfied DNR and the boil order was lifted.
- 3. Staff now advises the Commission that it has inspected the facilities at Moore Bend and verified that all necessary improvements have been completed and that

the correct procedures are taking place to allow for proper detention time to thoroughly disinfect the water as required by DNR.

- 4. Staff further advises the Commission that DNR has assured it that Moore Bend is now compliant and that the boil order has been lifted.
- 5. No testimony has been filed herein by any party and no oral evidence has been adduced.
- 6. Staff believes that this case has been resolved and should therefore be dismissed. It is Staff's opinion that the public interest would not be served by further proceedings herein.

WHEREFORE, pursuant to Rule 4 CSR 240-2.116(1), Staff voluntarily dismisses this *Complaint*.
