## ORDER DIRECTING NOTICE AND SETTING DATE FOR SUBMISSION OF INTERVENTION REQUESTS

On November 14, 2006, the Consolidated Public Water Supply District No. 1 of Clark County, Missouri, and the City of LaGrange, Missouri, filed a joint application seeking approval of a territorial agreement concerning part of Lewis County, Missouri. Section 247.172, RSMo 2000, requires that such territorial agreements be submitted to the Missouri Public Service Commission for approval. The statute provides that the Commission may approve the submitted territorial agreement if it determines that the amendment is not detrimental to the public interest.

The Commission finds that notice of this application should be given to the general public and potentially interested parties. A date for intervention of proper parties should also be set. The Commission's Data Center shall mail a copy of this notice to the County Commission of Lewis County and to the Department of Natural Resources of the State of Missouri. In addition, the Commission's public information officer shall make notice of this

order available to the media serving Lewis County and to the members of the General Assembly representing Lewis County.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary.

- 1. The Missouri Public Service Commission's Data Center is ordered to serve notice as set out herein.
- 2. The Missouri Public Service Commission's information officer is ordered to serve notice as set out herein.
