

Motion to Reschedule Prehearing Conference

Comes now Complainants¹ and for their Motion to Reschedule Prehearing
Conference state to the Missouri Public Service Commission (Commission) as follows:

1. On July 22, 2003, the Commission issued its Order Setting Prehearing

Conference and Requiring Filing of Procedural Schedule in the above-referenced matter. Essentially, the Commission has directed the parties to appear at a prehearing conference scheduled for 10:00 a.m. on August 5, 2003 for the purpose of discussing possible dates for the filing of testimony and for hearing or, in the alternative, pursuing further settlement discussions.

2. At the present time, Counsel for Complainants is scheduled to participate in another hearing before the Commission scheduled for August 5 and 6, 2003. While it is very possible that hearing will be canceled, Counsel was also previously scheduled to attend the MTIA Annual Conference in Branson, Missouri on August 4 through 6, 2003. Counsel for Complainants has discussed the possibility of rescheduling the prehearing conference to the following week with counsel for Respondents (i.e., VoiceStream, Western Wireless and SWBT), Staff and Public Counsel and they have indicated no objection to same, however, the only date on which they all could be available was Tuesday, August 12, 2003.

WHEREFORE, in light of the foregoing, Complainants respectfully request the Commission to reschedule the prehearing conference to Tuesday, August 12, 2003, beginning at 10:00 a.m.; reschedule the date for filing a proposed procedural schedule to Friday, August 15, 2003; and for such other orders as are appropriate in the circumstances.


