MOTION TO CANCEL CERTIFICATES OF SERVICE AUTHORITY AND ACCOMPANYING TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and pursuant to Section 392.410.5 RSMo (Supp. 2008) moves the Missouri Public Service Commission ("Commission") to cancel the certificates of service authority and associated tariffs of KR&R Investment Corp. d/b/a Uplink ("Uplink" or "Company"). In support of the Motion, Staff states as follows:

- 1. On July 2, 1998, the Commission in case No. TA-98-408 granted Uplink a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, and approved the Company's submitted tariff.
- 2. On August 4, 1998, the Commission in Case No. TA-98-407 granted Uplink a certificate of service authority to provide shared tenant telecommunications services in the State of Missouri.
- 3. On July 31, 2009, Staff received correspondence from Uplink in response to demand letters for the Company's calendar year 2008 Annual Report submission. The correspondence indicated that the Company ceased business "approximately 20 [twenty] months ago and has had no revenues or expenses in this time period". Uplink requested the Company's certificates be canceled.

4. The Commission has the authority to cancel the certificate of service authority of a telecommunications corporation pursuant to Section 392.410.5 RSMo (Supp. 2008), which provides that "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

5. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

- 6. Uplink is current in the payment of its Commission assessments.
- 7. Uplink is delinquent in the filing of the Company's calendar year 2008 Annual Report.

WHEREFORE, the Staff recommends that the Commission cancel the certificates of service authority of KR&R Investment Corp. d/b/a Uplink to provide both intrastate interexchange and shared tenant telecommunications services and the associated tariffs.
