- I, JIM MERRILL, a natural person, do hereby swear and affirm that I am an officer or general partner of TELEXFREE, LLC ("Applicant"), and that the following statements are true and correct to the best of my knowledge and belief:
- (1) The location of the principal place of business and the names of the principal executive officers of the Applicant: 225 Cedar Hill Street, Marlborough, MA 01752. The two principle officers are myself and Carlos Wanzeler;
