

Motion to Amend Application
By Interlineation

Comes now Applicant Chariton Valley Telecom Corporation, and hereby moves to Amend its May 17, 2005 Application herein, by interlineation, to add the following paragraph 10:

“10. Pursuant to 47 CFR 54.201, Applicant requests that the Commission designate Applicant as an eligible telecommunications carrier for a service area designated as the Spectra Communication Group, LLC’s exchange of Macon, Missouri, a rural area under 47 CFR 54.5, that such designation is in the public interest, and that Applicant is eligible to receive support for each eligible line served in the Macon exchange in accordance with the per line amounts for a Zone 1 exchange contained in the disaggregation plan for Spectra’s study area No. 421151, as certified by Spectra pursuant to 47 CFR 54.315.”

In support hereof, Applicant states that the FCC Universal Service Rules, particularly 47 CFR 54.201(b) requires a state commission, upon its own motion or upon request, to designate a carrier meeting the ETC requirements as an ETC for a service area

designated by the state commission. The Universal Service Administration Company now requires said designation to specify an ETC's service area for purposes of administering USF support.

Relief Requested

Applicant requests that the Order designating Applicant as an ETC also designate that Applicant's service area is the Macon, Missouri exchange, that such designation is in the public interest, that Applicant is eligible to receive federal Universal Service support for each eligible line served in the Macon exchange in accordance with the disaggregation plan for Spectra's study area No. 421151, as certified by Spectra pursuant to 47 CFR 54.315."


