## ORDER OVERTURNING NORTH AMERICAN NUMBERING PLAN ADMINISTRATOR'S DECISION

Issue Date: May 15, 2007 Effective Date: May 15, 2007

On April 25, 2007, Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri filed an application and motion for expedited treatment, requesting that the Missouri Public Service Commission review and reverse a decision of the North American Numbering Plan Administrator (NANPA), NeuStar, Inc., of AT&T Missouri's application to obtain a thousands-block within the 636 NPA in the Festus-Crystal City rate center, confined to the 8000-8499 XXXX range, to provide service to a new manufacturing facility.

On May 14, 2007, the Staff of the Commission filed its Staff Recommendation. No other applications to intervene, requests for hearing, or recommendations have been filed. Staff recommended the Commission grant AT&T Missouri's request for a thousands-block within the 636 NPA in the Festus-Crystal City rate center, confined to the 8000-8499 XXXX range.

The Commission has the authority to overturn NANPA's decision to withhold numbering resources from a carrier pursuant to 47 C.F.R. §52.15(g)(4), which states in part, "The state commission also may overturn the NANPA's decision to withhold numbering resources from the carrier based on its determination that the carrier has demonstrated a verifiable need for numbering resources and has exhausted all other available remedies."

Based on Staff's recommendation, the Commission finds that AT&T Missouri has demonstrated a verifiable need for numbering resources and has exhausted all other available remedies. The Commission overturns NANPA's decision and approves AT&T Missouri's requests for one block of thousand telephone numbers as listed above.

## IT IS ORDERED THAT:

- 1. The North American Numbering Plan Administrator's decision to withhold numbering resources from Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri is overturned.
- 2. AT&T Missouri's request to receive a thousands-block within the 636 NPA in the Festus-Crystal City rate center, confined to the 8000-8499 XXXX range, is granted.
  - 3. This order shall become effective on May 15, 2007.

4. This case may be closed on May 16, 2007.
