On July 31, 2008, Charter Fiberlink-Missouri, LLC filed its petition for arbitration with the Commission pursuant to the Telecommunications Act of 1996. The petition asks the Commission to arbitrate its unresolved issues with CenturyTel of Missouri, LLC.

The arbitrator held an initial arbitration meeting on August 19. At that meeting, the parties provided the arbitrator legal authority for the proposition that, with the parties' consent, the 270-day deadline for resolving the parties' disputes can be extended for 90 days.¹ To that end, the parties submitted a Joint Memorandum Filing Proposed Schedule on August 21 that included dates beyond the otherwise mandatory 270 day deadline and within the 90 day extended period.

The arbitrator finds the dates the parties suggested reasonable, and will set the procedural schedule as follows.
