ORDER SETTING ADDITIONAL PUBLIC COMMENT HEARING

Public comment hearings have been scheduled in these cases in Reeds Spring, Shell Knob, Republic, Sedalia, and Jefferson City, Missouri. On April 29, 2008, the Office of the Public Counsel requested the Commission to set a public hearing in the Warsaw, Missouri, area. Public Counsel stated that it has received a request for such a public hearing on behalf of Aqua Missouri customers in that area, and cited the distance these customers would have to travel to the closest scheduled location, in Sedalia. The Commission also received a request from a Warsaw-area customer.

Having considered the requests, the Commission concludes that an additional public comment hearing in Warsaw, Missouri, shall be scheduled. At the hearing, the Staff of the Commission will hold an informal question-and-answer session beginning at 5:30 p.m.; the hearing will begin at 6:00 p.m. and will conclude at 9:00 p.m., or when every person who wishes to testify has done so, whichever is sooner. The Commission's Data Center and Information Office will be directed to provide notice of the hearing. In addition, the Commission will direct Aqua Missouri to provide notice to customers within a 30-mile radius of its Warsaw, Missouri, service area.

IT IS ORDERED THAT:

- 1. The Commission shall hold a public comment hearing on Monday, June 9, 2008, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, in the Community Learning Center (CLC) of the Warsaw High School, 20363 Lane of Champions, Warsaw, Missouri. The hearing will be conducted by videoconference.
- 2. No later than ten days prior to the public comment hearing, Aqua Missouri, Inc., shall provide an individual notice to each of its customers living within a 30-mile radius of Warsaw, Missouri, as set out below.
