ORDER SETTING LOCAL PUBLIC HEARINGS

Missouri-American Water Company submitted proposed tariff sheets designed to implement a general rate increase for water and sewer service. In its order suspending that tariff, the Commission directed the parties to file recommendations regarding the times, dates, and locations for local public hearings.

On May 15, the Office of the Public Counsel filed a recommendation asking the Commission to schedule local public hearings in various locations around Missouri-American's service territory. No party has objected. The Commission will therefore schedule local public hearings in the cities recommended by Public Counsel. All hearings will be held from 6:30 p.m. until 9:30 p.m. or until all persons who wish to testify have done so, whichever is sooner. A question and answer session will be held from 6:00 p.m. until 6:30 p.m.

2. The local public hearings shall be held in facilities that meet the accessibility requirements of the Americans with Disabilities Act. 3. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the county commission of each county in Missouri-American Water Company's service area.

4. The Public Information Office of the Missouri Public Service Commission shall send a copy of this order to members of the General Assembly and to the media that serve Missouri-American Water Company's service area.

5. Missouri-American Water Company shall provide notice of the local public hearings as set out in the Commission's Order Granting Motion to Modify Notice Provisions issued on July 2, 2008.

6. Missouri-American Water Company shall place advertisements in the newspapers serving its service territory. The advertisements shall contain the information from the customer notice relevant to the customers in the newspaper's circulation area.

7. This order shall become effective on July 15, 2008.
