

ORDER SCHEDULING LOCAL PUBLIC HEARING

Issue Date: September 21, 2007 Effective Date: September 21, 2007

The Staff of the Commission has filed a compliant against Universal Utilities, Inc., and Nancy Carol Croasdell alleging that they are operating a water and sewer utility without a required certificate from this Commission. On September 18, 2007, the Office of the Public Counsel filed a request asking the Commission to conduct a local public hearing in Columbia, Missouri, near the Blue Acres Mobile Home Park, which allegedly receives water and sewer service from the Respondents.

The Commission will grant Public Counsel's request and will schedule a local public hearing. The local public hearing will begin at 6:00 p.m. and will conclude at 9:00 p.m., or when every person who wishes to testify has done so, whichever is sooner. The Commission will direct its Public Information Officer to provide notice of the local public hearing to the residents of the Blue Acres Mobile Home Park via any reasonable and

appropriate means, including but not limited to placing advertisements in the newspapers serving that service area.

IT IS ORDERED THAT:

- 1. A local public hearing shall be held on Monday, October 29, 2007, from 6:00 p.m. until 9:00 p.m., or until all persons who wish to testify have done so, whichever is sooner, in Room 130 of the LeMone Building, 3215B LeMone Industrial Blvd., Columbia, Missouri, which meets accessibility standards required by the Americans with Disabilities Act. Any person needing additional accommodations to participate in the local public hearing should call the Missouri Public Service Commission's Hotline at 800-392-4211 or dial Relay Missouri at 711 at least 48 hours in advance of the hearing. A video-conference link shall be established with the Commission's offices in Jefferson City.
- 2. The Commission's Public Information Officer shall send a copy of this order to members of the General Assembly and to the media that serve the Blue Acres Mobile Home Park. The Public Information Officer shall also provide notice of the local public hearing to the company's customers via any reasonable and appropriate means, including but not limited to placing advertisements in the newspapers serving the Blue Acres Mobile Home Park.

3. This order shall become effective on September 21, 2007.
