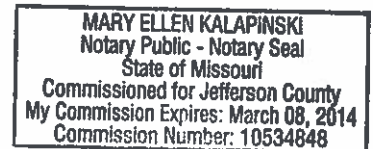
1. AT&T Missouri agrees to comply with all applicable federal and state laws and regulations.


