## SUPPLEMENT TO TRIENNIAL COMPLIANCE FILING

COMES NOW The Empire District Electric Company (Empire or Company), and, as a supplement to Empire's 2013 Triennial Compliance Filing, states as follows to the Missouri Public Service Commission (Commission:

- 1. On July 1, 2013, The Empire District Electric Company filed with the Missouri Public Service Commission its 2013 Integrated Resource Plan, which is required by the Commission's Electric Utility Resource Planning rule, 4 CSR 240-22.
- 2. Commission Rule 4 CSR 240-22.080(2)(A) states that the filing shall include "[I]etter of transmittal expressing commitment to the approved preferred resource plan and resource acquisition strategy and signed by an officer of the utility having the authority to bind and commit the utility to the resource acquisition strategy."
- 3. While Empire provided a transmittal letter and expressed that the Preferred Resource Plan's resource acquisition strategy had been formally approved by the Company, it inadvertently neglected to provide a letter signed by an officer of the Company.
- 4. Accordingly, Empire seeks to supplement its Triennial Compliance Filing by providing the attached Appendix A, which is a letter and signed by an officer of the utility having the authority to bind and commit the utility to the resource acquisition strategy.

WHEREFORE, Empire respectfully requests that the Commission consider this supplement and issue such orders as the Commission deems just and proper under the circumstances.
