ORDER APPROVING TARIFF

On July 10, 2012, YMax Communications Corp. filed tariff revisions, later substituted on July 31 and September 9.¹ The tariff sheets bear an effective date of October 23.

AT&T Communications of the Southwest, Inc., ("AT&T Communications"), Southwestern Bell Telephone Company, d/b/a AT&T Missouri ("AT&T Missouri"), and Verizon Business Services ("Verizon") intervened and objected to the initial tariff filing. However, after the substitute tariff sheets were filed, the intervenors withdrew their objections.

Staff filed a Recommendation on October 5, stating that it requests that the Commission approve the tariff sheets.

Based upon the intervenors' withdrawal of objections, Staff's favorable recommendation, as well as the Commission's independent review of the tariff, the Commission will approve the tariff sheets.
