Written response to KCP&L information request

Let us start by saying that we have an Earth Calm Infinity Home Protection system in our home. This system contains revolutionary Mirror Resonance Technology (MRT), which utilizes proprietary geometric circuits to mirror the structure of the Earth's natural electromagnetic field (also known as the Schumann Resonance). MRT works by transmuting the man-made EMF, from a harmful field to a beneficial one. This system protects against any harmful effects from laptops, cell phones, cordless phones, home electricity and microwave radiation devices including Wi-Fi routers. We noticed about 4 years ago that our two older boys (now 12 and 8 years old) were having hyperactivity and concentration issues. This was a problem because we homeschool our children and these issues were having a harmful effect on their school and health in general. After researching some possible causes, we decided that there could be a link between EMF exposure from devices in our home and their hyperactivity. We decided to purchase an Earth Calm Home protection system to see if this would help in alleviating some of these problems our children were having. We also added another layer of protection by purchasing a product from Earth Calm that plugs directly into our Wi-Fi router that negates any adverse effects caused by it. We noticed a drastic change in their behavior. It was like they were finally able to be calm and focus/concentrate again. It made a big difference in our school and family life. Things were once again running smoothly.

Things started heading south again starting January 20th, 2016. At this time, a digital smart meter was placed on our home. I remember I was nursing our most recent son at the time. I heard a loud knock on our door but was unable to get it since I was nursing our son, Conrad. Only moments later I heard an awful noise that disrupted our son from nursing and I went downstairs to find a note on our door saying they had changed our meter. I did not think too much of it and continued to finish feeding our son and put him to bed. He was very healthy with no problems before I put him down for his nap. He took about a 2 hour nap and then woke up screaming. I went in to check on him and noticed that he had a rash on his face. I thought that was strange since he was fine when I put him to bed. Since the installation of the smart meter, his rash continued to get worse and

worse. People would comment on it if I took him to church, or out of the house. We took him to the doctor on January 29, 2016 since it had not gone away. The doctor recommended that the meter be changed back to our old meter because it was having detrimental effects on our son's skin and his ability to sleep. I was also experiencing acute insomnia as well as body aches, mind fog, memory loss, irritability and eczema along my hairline that kept getting worse. Our two older children were exhibiting their old symptoms of hyperactivity and lack of focus and concentration. Having our meter changed was the only thing that had happened. I started to research the effects of smart meters (I already had some prior knowledge of EMF's since dealing with it the first time with our two older children and purchasing an Earth Calm Home Protection System) and found that all of our symptoms were directly related to the low level radiation that was being emitted from our smart meter. I called Earth Calm to see what we could do. We already had a home protection system and protection for our Wi-Fi. They said that it was a cumulative effect and that the smart meter just added too much for our system to protect us fully. They recommended that we take our little protection device that we had plugged into our router, and tape it to the bottom part of our meter to see if that would help alleviate some of the radiation that it was emitting. We did that and immediately noticed a change again. The very next day both my rash and my son's rash started getting better. I could sleep better and so could my son, Conrad. We have had to now function without a router since we do not have any protection for it since it is on our smart meter now. If we have to use the computer, we will plug our router in for 5-10 minutes to use it but, otherwise, our router remains unplugged at all times.

I remember several instances where my body would start aching and I could not sleep for at least 3 nights in a row, I finally remembered to go look at our smart meter and I noticed that someone had taken off our protection device we had placed on the bottom. Thankfully, it was still there, so I taped it on again. Our symptoms were once again immediately better. The only ones who have not had their symptoms relieved back again are our two older boys. Since our smart meter was placed on our home in January, they continue to exhibit hyperactivity and a lack of focus and concentration for school. It is effecting their school in an adverse way.
