STAFF'S NOTICE OF STAKEHOLDER MEETING SET FOR OCTOBER 1, 2009

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and submits its Notice of Stakeholder Meeting Set For October 1, 2009 to the Missouri Public Service Commission (Commission) stating as follows:

 On April 8, 2009, the Office of Public Counsel (OPC) filed its Petition to Open a Workshop Docket, designated file nos. WO-2009-0362 and SO-2009-0363, to allow stakeholders, interested entities, and the Commission to explore the problems facing Commission regulated small water and sewer companies and develop solutions.

2. On April 10, 2009, the Commission issued its order directing Staff to respond.

3. On April 13, 2009, Staff filed its response supporting such a workshop docket, stating that "eighteen (18) small water and sewer rate cases [were pending], in addition to application cases, formal complaints and other inspections and investigations." Staff noted that "the vast majority of the small water and sewer rate cases filed will be completed by the end of August 2009," and therefore requested a deferral of the workshop docket until August 20, 2009, to prepare, organize and hold the initial meeting.

4. On May 1, 2009, the Commission opened the above referenced working case to "invite the public and interested utilities to submit written comments describing the problems facing small water and sewer utilities, and offering possible solutions to those problems. After those comments are collected, the Commission may schedule a workshop at which interested persons can gather to discuss the identified problems and solutions."

5. Multiple small water and sewer utility comments have been filed in this case beginning June 10, 2009.

6. On June 5, 2009, the Commission held a Water Symposium to inform small water and sewer utilities of topics including the Missouri Department of Natural Resources new requirements and available programs, and the federal Environmental Protection Agency's program and educational opportunities regarding asset management assistance.

7. On August 12, 2009, the Water and Sewer Department Staff held an internal meeting where an estimated twenty Staff members discussed what major issues seemed to be consistently arising in small water and sewer cases.

8. As of August 22, 2009, eighteen water and sewer rate increase cases were filed and closed pursuant to the newly effective Small Utility Rate Case Procedure 4 CSR 240-3.050, effective May 30, 2008.¹ Of these 18 cases, five rate increase request cases were withdrawn by the companies.

9. Further, as of the date of this filing, ten additional water and sewer rate increase cases have been filed under the Commission's new Small Utility Rate Case Procedure Rule, 3.050.

10. On September 1, 2009, OPC filed its request for the Commission to set a small water and sewer utility workshop.

11. As of September 3, 2009, Staff will send the letter attached hereto, labeled Attachment A, inviting companies to participate in an open forum discussion on October 1, 2009, regarding issues impacting small water and sewer utilities in Missouri. A similar letter will be sent to stakeholders and interested entities also on September 3, 2009. This October 1st date was chosen

¹ The Commission issued an Order Approving Tariff Filings in Compliance with Commission Order in four cases, with an issue date of August 31, 2009, and an effective date of September 12, 2009. Therefore, technically these four cases will close as of September 12, 2009.

to give sufficient notice for those interested to make arrangements to attend. Also, to begin the discussion, this letter highlights the major issues Staff identified in its internal meeting.

12. Due to the completion of eighteen rate increase cases, along with the ten currently pending small water and sewer cases filed under 3.050, this open forum should allow companies and interested entities to evaluate problems known and discovered through the rate case process and other cases; review creative solutions already proposed within the context of those cases, and any approved, through the rate case process; and discuss the strengths and weaknesses of the small water and sewer rule itself and propose corrections.

13. Once this initial open forum is conducted, it should be clear what major issues should be the focus of workshops for entities to work toward resolution of the most problematic issues.

14. Staff believes it is not necessary at this time for the Commission to set a workshop date.

WHEREFORE, the Staff submits its Notice of Stakeholder Meeting Set For October 1, 2009, for the Commission's information and attention.
