**OFFICE OF THE PUBLIC COUNSEL'S VOLUNTARY WITHDRAWAL OF  
MOTION TO REJECT TARIFF OR, IN THE ALTERNATIVE, SUSPEND TARIFF**

The Office of the Public Counsel voluntarily withdraws its Motion to Reject Tariff or, in the Alternative, Suspend Tariff, without prejudice. The motion was filed on May 9, 2006 with electronic service to counsel for the applicant and the General Counsel's Office. On that same day, applicant's counsel advised Public Counsel that the applicant would amend its proposed tariff to remove the \$.99 monthly charge from the proposed tariff. On May 10, 2006, counsel for applicant filed the replacement tariff page for Nationwide Long Distance Service, Inc., Case No. XA-2006-0409; Tariff No. YX-2006-0803 to remove Section 4.10 that established the Carrier Cost Recovery Charge.

With the deletion of Section 4.10, Public Counsel's motion is now moot so Public Counsel voluntarily withdraws its motion, without prejudice.
